

Applications for the Medically Complex Children's Waiver will be accepted during an open application period May 1-31, 2017.

**Purpose:** This program provides medical assistance to children who are medically complex. This waiver serves the following population:

- Children ages 0-18
- Children who have 3 or more specialty physicians
- Children who have 3 or more organ systems involved in their disability
- Children who have a SSI Disability Designation through the SSA or a disability determination by the State Medical Review Board, this will be coordinated as part of the MCCW application process.

### Children enrolled in the program will have access to Traditional Medicaid Services and Respite Services

Applications will be accepted online through the webpage, via fax or mail. The application process will require parents to answer some questions about their child's medical conditions and services. In addition, parents will be required to provide a copy of the child's most recent history and physical by the Primary Care Provider. # Medically Complex Children's Waiver (MCCW) Open Enrollment

#### Applications Accepted May 1-May 31, 2017

# Medically Complex Children's Waiver – Application and Program Details Frequently Asked Questions for Parents and Families

#### 1. How do I apply for the program?

Applications for the Medically Complex Children's Waiver (the program) will be accepted online (at http://health.utah.gov/ltc/mccw), via fax or mail from May 1- May 31, 2017. The application process will require parents to answer some questions about their child's medical conditions and services. In addition, parents will be required to provide a copy of their child's most recent medical history and physical (or Well Child Check) by the child's physician.

#### 2. How many children will be enrolled in the program?

The program was authorized by the Utah State Legislature as a pilot program (HB199) that will run through June 30, 2018. Additional funding was appropriated in the 2016 Legislative session. During the open application period the Department will evaluate available funding and determine how many new children can be added to the program. If the number of qualified applicants exceeds the number of available program openings, HB199 requires the State to prioritize entrance into the program based on highest medical complexity and critical needs of the family.

#### 3. What services will be available in the program?

Children enrolled in this program will have access to respite services, as well as traditional Medicaid services. Children enrolled in the MCCW program will receive services through Fee for Service Medicaid rather than through Accountable Care Organizations (ACO's).

# 4. The State requires a copy of the most recent medical history and physical (or Well Child Check). What does this mean?

As part of the program application, the State requires a copy of your child's most recent medical history and physical (or Well Child Check) from the child's physician. This documentation must include past medical and surgical history, problem or diagnosis list, active medication list, allergies, vital signs, physical exam and a plan of care. 5. Is financial eligibility for the program based on parental or family income? No, eligibility for the program is based ONLY on the child's income and assets.



#### 6. What if we've applied for Medicaid coverage before and been denied?

It doesn't' matter if your child has been denied for Medicaid before, your child may still be eligible for the MCCW program. The financial eligibility requirements for this program are different from typical Medicaid requirements. For this program, ONLY your child's income and assets will be used to determine eligibility.

## 7. To be eligible for the program, is my child required to have a specific medical diagnosis?

No, your child is not required to have a specific medical diagnosis.

#### 8. What are the other eligibility requirements?

To be eligible for the program, the child must meet the following requirements:

- Be 0 through 18 years of age;
- Have 3 or more specialty physicians, in addition to their primary care physician;
- Have involvement of 3 or more organ systems;
- Demonstrate a level of medical complexity based on a combination of need for device-based supports, high utilization of medical therapies, and treatments and frequent need for medical intervention; and
- Have a level of disability determined by the State Medical Review Board. (See Question 9 for more information on this item.)

### 9. What does it mean to have a determination of disability by the State Medical Review Board?

The language in HB199 requires children to have a certain level of disability in order to qualify for the program. The level of disability must be determined by the State Medical Review Board. As part of the Medicaid eligibility determination process, the State will work with families to arrange to have a disability determination completed through the State Medical Review Board. Some families may have already worked with the SSA to obtain a SSI disability determination this determination may be used as part of the Medicaid eligibility determination.

## 10. My child already has health insurance coverage. Can my child still qualify for the program?

Yes, the program is intended to assist with covering the substantial medical costs associated with caring for a child with disabilities and complex medical conditions, whether the child currently has other medical insurance coverage or not.
